# Q1) Dion, Start from the beginning and tell me everything in regards to what you witnessed today?

A1) We got together to get the snowmobile, we went across Strawberry head and into the Harbour, we got off and started walking out. We stopped looking around for the snowmobile, she was out of sight behind the rough ice. We carried on out further, and then we were walking along and about 50 yards in front of us we just seen the hood of her. She was up against the rough Ice jammed in. We had to beat the rough Ice off and then we hauler her out. We followed are track back then to the other snowmobiles, then came in through Fords bite and along to the office.

# Q2) What time did you recover the snowmobile?

A2) About 11:30 A.M.

# Q3) Tell me everything you noticed about the snowmobile?

A3) We noticed a small crack in the right side of the windshield. One of the screws was popped out of the front of the windshield. The key and kill switch was shut off. Gas can was 8 feet off behind the back of the snowmobile.

# Q4) Did you start the snowmobile?

A4) Yes, 7 - 8 hauls she went right away, There was nothing wrong that skidoo.

## Q5) Do you notice anything else around the snowmobile?

A5) A few foot prints walking back from her, he was walking around her almost like he was looking for a way to Shore, there was water all around the him. The gas can was 10 feet back, it was full.

## Q6) Did you notice any snowmobile tracks?

A6) Yes, coming from outside, following the crack. We walked back to see where he came from, he was outside further and he was coming back in.

- A10) Yeah.
- Q11) Was the snowmobile hard to find?
- A11) Yes, it was rough ice.
- Q12) Explain the ice conditions around the snowmobile?
- A12) Froze up good now, A lot of rough ice, right in among the rough ice, the height of the ice around the snowmobile is about 4 feet.
- Q13) Who recovered the snowmobile?
- A13) Perry VOISEY, Andy EDMUNDS, me.

## 2012/01/29

#### 19:40

On the above noted date and time writer received information from Cpl VARDY that Rodney and Natalie JACQUE were looking for there 14 year old son, Burton WINTERS. Writer was advised that WINTERS had not been seen since 13:30 HRS on today's date. Writer was advised that WINTERS was last seen driving a yellow Tundra 300 snowmobile. It was reported that WINTERS was suppose to travel to his grandmother house which in located next to Cpl VARDY residence.

#### 19:40

Writer headed toward Cpl VARDY residence, on route member ran into Willie FLOWERS, Burton's best friend. Willie advised that WINTERS had dropped him off today at 13:30, Willie had not seen him since. Willie could not provide a direction of travel or any further information that would help assist police. Willie did advised that WINTERS does not usually go far on snowmobile, far as the dump and Ranger Bite and using some back paths around the town but never leaving down. Writer spoke to Cpl VARDY who advised that Mike BISHOP and Rodney JACQUE (Burtons Father) were going to travel to Killman Pond to see if there was any sign of WINTERS. It was reported that WINTERS had been out with the Canadian Ranger earlier in the day and they had been in the Killman Pond area.

## 19:45

C/Cst ANDERSEN was contacted and several hasty searches of the area were organized. ANDERSEN and fisher officer Denley JACQUE advised they would travel to Killman Pond and out through Fords bite as the Rangers had come home that way earlier in the morning. Several other search teams were deployed to sweep the surrounding areas, including routes between Makkovik and Postivlle. The following places were searched:

The Family was kept abreast of efforts from Search Teams.

Police Spoke with Family and were able to gather the following information.

- Burton was operating a 2008 Skandic, Tundra, Yellow in colour.
- Burton was last seen approximately 13:30 on today's date.
- Burton had empty gas can on back of snowmobile.
- Unclear as if it was tied in the rack or not.
- Burton is 14 yrs old.
- Burton is not very mechanical sound.
- This is Burton's first year operating a snowmobile.
- Burton is not a experienced hunter or experienced on the land.
- Burton does not smoke ( Doubtful he is in possession of a lighter or matches )
- Burton said he was going to his grandmothers.
- Burton was out with the Canadian Ranger earlier in the day.
- Burton had lunch around 12:30.
- Burton left the residence with Willie FLOWERS.
- Burton did not appear to be upset.
- Burton is a quiet kid.
- Burton was a member of the Rangers.
- Burton does not usually go on the ice, told to stay off it by his dad, Rodney JACQUE.
- No history of mental illness.

Note: It was reported that Burton has been spoken to by his parents before lunch on this date in regards to being on computed until 4:00 AM, Buton's computer was taken however he didn't appear to be upset regarding same.

## 23:46

Ryan POTTLE and Perry Lee EDMUNDS attended the detachment to advise they left Makkovik today to go hunting, they seen a track coming out the bay heading toward the edge of the ice. They advised it was a single snowmobile track not towing a komitak, did not appear to be a widetrack. Track appeared to be a out of the ordinary as they did not know who else would be out on the bay. At this point most areas in the general vicinity had been searched.

#### 01:00

Back at detachment, Search teams were debriefed on track leading toward ice. Plan made to send a limited amount of snowmobiles to chase the track, all equipped with Floater suit and rope, all were radios to have direct contact with detachment.

#### 01:45

Search team returned from the harbour, Perry VOISEY and Andy EDMUNDS had chased the track toward the open water, both advised that the track was leading toward bad ice and it was extremely dangerous, especially for a search in the night.

#### 02:30

Search ended for the night, plan made to meet back at detachment at 7:00 AM to continue with search. Family was updated and advanced message was forwarded in regards. Cpl VARDY was in contact with Sgt YOUDEN attempting to arrange a helicopter for first light.

RCMP Air Services on ground in Makkovik. Cpl VARDY and Cst ANDERSEN took possession of underwater camera, both to bring same to scene.

Randy EDMUNDS, Errol ANDERSEN, Travis DYSON and writer aboard platus, members to fly over area to try and locate any debris.

#### 15:54

Writer observed snowmobile, machine located approximately 2.5 km's past track located heading toward open water. Snowmobile in upright position, gas can appeared to be 6 feet behind the snowmobile laid in a upright position indicating it was physically placed. Detachment and search members on ground advised of new information. Ice around machine appeared to be very unsafe, lots of cracks between pans, Machine located approximately 400 yards off shore in rough ice. Nothing else spotted.

0745hrs Ground searchers deployed to Strawberry head shoreline.

0811hrs Ground Searchers were deployed to head South East over to Big Bight, Manaks Island and Adlavik to check the area for any signs.

0834hrs Member spoke with RCMP pilot Wayne WINSOR to advise if they are in the area over Makkovik to keep an eye out. WINSOR advised they were on weather hold out of Goose Bay.

0843hrs Ground Searchers from Postville travelled from Postville to Makkovik checking Kaipokok Bay, Marks Bight and Makkovik Bay for the second time.

All commercial airservices operating in the area of Makkovik were notified of the search for the missing youth and asked to keep an eye out when flying over. RCMP Airservices was contacted and advised of the same. Member was advised that all aircraft was on hold due to poor weather conditions.

0850hrs Member contacted Sgt. Lloyd YOUDEN inquiring about the availability of 444 Squadron.

0902hrs Member was advised by Sgt. YOUDEN that the Universal Helicopter tasked to travel to Makkovik to assist with the search was on weather hold.

1000hrs it was learned that there was a helicopter from WOODWARDS Oil in Postville and it was heading to Makkovik to assist with the search efforts.

1005hrs Member spoke with Sgt. Lloyd YOUDEN and advised that the WOODWARDS aircraft was in the air and that the weather had improved. Universal Helicopters was notified and they advised they were enroute with an ETA of around 1200hrs.

1016hrs Member spoke with Sgt. Lloyd YOUDEN about the DFO plane that has FLIR capabilities. Sgt. YOUDEN advised he was waiting on a call back from Paul PEDDLE

1034hrs Received a call from Universal Helicopters, Brian, who advised he was enroute and gave an ETA of 1200hrs.

1040hrs WOODWARDS helicopter on scene, Tasked to search area around Makkovik toward the ocean. See C/Cst ANDERSEN's Supp Report.

1200hrs Universal helicopter on scene.

1220hrs C/Cst. ANDERSEN confirmed the snowmobile track heading into open water off Strawberry Head. C/Cst. ANDERSEN advised that the open water was 60ft across the crack and another 300-400ft of fresh ice. Given that the victim was traveling on a 300cc Tundra snowmobile it would be highly unlikely to have made it across the open water. Searchers checked the shoreline in from the open water to Strawberry Head looking for any sign of footprints. Searchers also checked the open water for any sigh of debris to confirm that the snowmobile had gone into the water. Neither was located.

0730hrs Member was notified by Cst. BABSTOCK the camera was delivered to the PAL counter in Deer Lake.

1554hrs Member received confirmation from Cst. HOWLETT that the snowmobile had been located approximately 2.5kms past the open water and up right on the ice. Cst. HOWLETT advised that the snowmobile was out on a pan of ice with several open water cracks around the area and between the snowmobile and the shore. He advised that the gas can was located behind the snowmobile approx 6ft and in an upright position as if it had been placed there intentionally.

Member immediately made a second request for airsupport through Fire and Emergence Services. Member was advised that an aircraft would be dispatched from Halifax. A few minutes later Member received notification that the 444 squadron in Goose Bay was completing their maintenance and would be dispatched to the scene.

Searchers were notified of the update and tasked to check the shore along the edge of Strawberry Head out toward Nipper Cove.

1805hrs Ground searchers were unable to locate any sign along the shore. They had difficulty along the terrain due to ice, cliffs and the unset of darkness. The teams were advised to return to Makkovik.

1829hrs member was contacted by Capt. Christian MacDONALD of JRCC 902-427-2100, started working closely with him on giving information about the search area and the location of the snowmobile. Also receiving information on the progress of 444 Squadron. Member was going to see if the 444 Squadron was able to take C/Cst ANDERSEN on board to assist with their search and to give local knowledge of the area. Member was advised that the 444 Squadron would be flying directly to the area from Goose Bay and not dropping into Makkovik until they were in need of fuel. Member was advised that the 444 Squadron had a short window of opportunity as their flying day would have to end at 0100hrs as their allowable work day would be exceeded. They would be required to take a 12 rest period and would not be available again til after 1300hrs the next day. Member inquired wether they could take their rest period in Makkovik to make them closer to the search area but was advised they would have to go back to Goose Bay due to not being able to secure the aircraft.

2100hrs the 444 Squadron was on scene and conducting searches in the area of the located snowmobile.

2123hrs Members received confirmation from Capt. MacDONALD, JRCC Halifax, that the snowmobile had been spotted and they were conducting a grid search.

2203hrs Members met with the 444 Squadron aircraft as it returned to Makkovik to refuel. They had nothing new to add but advised they were continuing with the search.

2316hrs Member was advised through JRCC that an Aurora aircraft was enroute from St. Anthony with FLIR capabilities to search for heat sources. Member was asked if there were any searchers in the area of the area to be searched. Member advised that all searchers had been recalled from the area.

2330hrs the Aurora was on scene

0115hrs The 444 Squadron had returned to Makkovik. Member spoke with the pilot who advised they picked up a track walking from the snowmobile headed south toward the closest point of land. The track went for 100-150ft. then disapeared. The 444 Squadron advised they were done for the night as they had maxed out their flying hours. The Aurora completed its search around the same time, negative results.

Member spoke with Paul PEDDLE of Fire and Emergency Services who made arrangements to have a helicopter from Goose Bay to come to Makkovik for the first thing in the AM.

At aproximately 1945hrs on Sunday January 29 2012 C/Cst. Barry ANDERSEN, hereinafter as ANDERSEN recieved a call from Cst. Stephen HOWLETT regarding a missing person, Burton WINTERS. ANDERSEN was advised WINTERS had not returned home for supper today and nobody seems to have seem him since 1330hrs on 2012-01-29.

NOTE: ANDERSEN is the 5th Canadian Ranger Patrol Group leader of the Junior Canadian Rangers (JCR's) for the Makkovik Patrol. Burton WINTERS is a JCR in this patrol. On January 28-29 2012 the JCR Makkovik Patrol had a two day Field Training Excerise(FTX). Training module was Tradition Skills Weekend. (Build fires, set rabbit snares, observed moose being paunched and quartered, skinned rabbits that was caught etc.) JCR's travelled to Killman Pond aproximately 6KM south west of Makkovik. WINTERS participated in this training both days. JCR's were assisted in fueling up their snowmobiles at Makkovik near ANDERSEN's residense by patrol leadership staff. ANDERSEN personally filled WINTERS Tundra 300 snowmobile gas tank to capacity with 23L of gas at aproximately 0930 on January 28 2012 in preparation for the two day FTX. Upon completion of the FTX on Sunday January 29 2012 WINTERS answered the roll call at 1145hrs along with the other 14 JCR's near the JCR sea-can storage container at Makkovik, NL before JCR's were released back to family as per protocol. At aproximately 1230hrs ANDERSEN saw WINTERS driving on Middle Path Rd towards the Post Office. ANDERSEN did not notice where WINTERS turned from there but his Grandparents home is just a few houses up the road in direction he was travelling. He was alone and dressed as he was for the FTX.

ANDERSEN was advised that WINTERS dad and Mike BISHOP had been looking around town for WINTERS but there was no sign of him or the snowmobile he was driving. Friends had posted messages on Facebook for WINTERS to call his mom or dad as it was unusual for WINTERS not to return home or attend his grandparents home for dinner or suppers. ANDERSEN was able to speak with Rodney JACQUE, WINTERS dad to see if he knew where he may have went. JACQUE stated that WINTERS did not venture far. Just as far as the dump and to Indian Head or Ranger Bight which is just past the School to the west of Makkovik. JACQUE stated that he was cutting firewood not far from where the JCR had the FTX yesturday and today and that WINTERS knew where his wood path was. JACQUE said he returned home just prior to supper time on January 29/12 and did not see his son in that area. Weather conditions were light snow with heavier snow squalls later in the afternoon and evening.

ANDERSEN mustered three GSAR teams consisting of two members each to do a quick hasty search of the general area of all snowmobile trails leading out of Makkovik. Travis DYSON and Perry DYSON went to Bens Cove area leading north towards Hopedale snowmobile trail. Roy MARTIN and Errol ANDERSEN went to Makkovik Bay area which leads to Postville and they also checked the many cabins in Makkovik Bay and Boats Cove and going as far as Cape War aproximately 16KM from Postville. ANDERSEN and Denly JACQUE conducted a hasty of the entire area the JCR's travelled in the last two days. Hasty searchs were negative. At 2121hrs ANDERSEN/JACQUE returned to Makkovik.

An only lead that was of any significance came from Ryan POTTLE stateing that he had seen fresh snowmobile tracks heading out Makkovik Bay towards the edge of ice. A search party including Perry VOISEY a very experienced hunter with great knowledge of salt water ice was tasked with following the tracks to see where it lead. Due to heavy snow and darkness and very thin ice according to VOISEY the party had to turn back. VOISEY was adimant that the track continued on out towards the open

2012-01-30 1040

ANDERSEN, Perry DYSON, Errol ANDERSEN boarded helicopter owned by Woodwards Oil, All three members familiar with and had experience in helicopter safety procedures. ANDERSEN directed pilot to areas to search first. From take off we proceeded to Fords Bight point flying low over the shore line from Makkovik hr. Weather was light snow with cloud cover causing "blinding" conditions. This means we could not see where the sea ice horizon ended and the clouds began. It is all the same white/grey color. Very dificult to see any tracks on the snow as well. Winds were light from the west. No sign was seen from Makkovik to Fords Bight Point. Directed pilot to Strawberry Head over sea ice. Turned northwest from the edge of ice which was a lead approximately 20m wide with another 50M of very thin ice or slob to the outside edge towards the north east looking out to sea/open loose ice covered by nearly 100% as far as we could see in the snow. Flew NW to Ikey's Point over the inside of the ice edge. No sign of anything. Flew back over the outside of the lead to Strawberry Head. Saw fresh polar bear tracks following the lead towards Strawberry head. No sign of anything else. Directed pilot to fly back to Ikey's point on the north side of Makkovik Bay. The open water stretched completely across Makkovik Bay from Ikey's Point to Strawberry Head. From Ikey's Point a deliberate grid search was conducted sweeping from Ikey's Point to Strawberry Head and back west to Makkovik. This covered the entire Makkovik Bay area from ice edge to Makkovik. Grid pattern was aproximately 300m apart. No sign of any track at all. Directed pilot to head back to Strawberry head. From Strawberry hd we went to Jacko's Island and searched the entire island and it's shoreline. Went back over the polar bear tracks and headed back towards Ford's Bight. Just over the open water area the pilot stated we had a problem and had to land immediately. She asked if the ice was thick enough to land on. All three of us on board said no it was not. By then GSAR team was arriving at Strawberry head by snowmobile. Pilot stated that she was headed for Strawberry Head to land due to a "chip light" which is serious. Landed safely on top of Strawberry head. Helicopter shut down. GSAR members came up to see helicopter. No sign of WINTERS. As GSAR members were assisting the pilot by calling her base machanic and using a snowmobile as a ledge to get up to the engine cowling ANDERSEN was notified that there was possible snowmobile tracks sighted by Perry VOISEY who was making his way along the ice edge walking with Andy EDMUNDS and Perry Lee EDMUNDS. ANDERSEN and Perry DYSON went down to the ice edge and proceeded out to VOISEY and his two sons the EDMUNDS's. Writer was in front and DYSON was behing by about 4m. DYSON yelled shit. ANDERSEN looked back and DYSON had gone into a hole to his armpits. ANDERSEN crawled back hauled DYSON out. DYSON rubbed light snow over his clothes to absorb some of the water and said he was ok to continue on to VOISEY. At aproximatey 1220 the sky lightened up and ANDERSEN could clearly see snowmobile tracks on the salt water ice running perpandicular to the ice edge heading in a NE or SW direction. Notified Cpl. VARDY and requested a camera to photograph the tracks before they covered up. 1310hrs Cst. HOWLETT arrived with camera by chopper but by then light conditions had changed to dull. Errol ANDERSEN met ANDERSEN with ropes to ensure safety in the area DYSON had went through. Photos of the tracks taken. Four GSAR team members headed back to get a boat to search water for any sign of WINTERS or debris.

- -Pilot advised that ice conditions did not look very good. He stated he could put down lightly and members could retrieve person. Pilot stated for ANDERSEN to remain in front seat until Errol and Randy got to the person.
- -Person carried to chopper. ANDERSEN could see it was as Burton WINTERS the person we were looking for. He has his coat off and hood over his face and upper body was covered by the coat. No mits on. Hat under his head along with goggles. No mits retrieved to no search time on ice. Body loaded into chopper by ANDERSEN. Coat put over his body. Cpl. VARDY advised by radio to of developements.

At no time in following the foot prints did WINTERS appear to stop, walk in circles or rest. There appeared to be a dilberate effort to get from one point to the next. However, we could not see the foot prints at all time. Chopper had to rise up on many occations as it was much easier to see the prints from about 500 feet.

Body transported by ANDERSEN and Cst. HOWLETT to Makkovik clinic. Cst. HOWLETT maintained continuity as ANDERSEN assited in getting GSAR team members back to Makkovik and briefed on outcome.

Writer received a laptop belonging to Burton WINTER on 2012-02-06 with a request to conduct an analysis on the computer looking at the users activity in the days leading up to his disappearance.

Writer conected the laptops hard drive to a forensic write blocker and previewed the drive with EnCase. Upon sorting all the files on the system by last access date it was clear that the last user activity on the system was the web browser Google Chrome. Writer extracted several Google Chrome SQLite DB files that contain user activity in order to get an idea of what the user was doing on the system. Writer was not able to see what content was being viewed but was able to get and idea of what a user was doing during there time online.

The first thing writer looked at was Google searches. 110 search strings were saved in the History file and all appeared general search strings such as music, videos, jokes, etc. Next looked was the downloaded files in which there were 30 and all appeared to be related to software, games, music, etc. In the URLS section a total of 3276 entries were found with most relating to Facebook and the rest being game sites, Google, etc. The Facebook URLS showed that he spent a lot of time looking at pictures (unsure of what) and talking with friends. The friends names were known but no actual conversations or messages were recovered. Also it was noted that the Mr. WINTERS Facebook username and password (password is encrypted) is saved so when he goes to Facebook it will log him in automatically. The family was wondering about accessing the account and they should be able to if the use the computer and the Google Chrome browser.

No documents, photos, or videos were located that were noteworthy.

Based on this writer is sending the computer back to the investigator so it can be returned to the family. It should be noted that this device was **not** imaged and once it is returned we will not be able to do any further analysis. It should also be noted that writer did not do a fully analysis on this device and no formal report will follow. The preview was conducted to confirm what investigators had already figured out. It should also be noted that when this device is connected back to the internet it may have access to data that is stored online (Facebook account etc) which may result in new information coming forward. If this is the case the website owners may have to be contacted to obtain this information as further analysis will not recover this data.

Member was present during the telephone conference between Rear Admiral DARDAM and the family. Member was contacted by the Commanding Officer for "B" Div. Chief Supperintendent BOLAND and asked to gather the parents of Burton WINTERS and some support persons. Member was asked to have them attend the RCMP office in Makkovik to receive a phone conference call from the CO and Rear Admiral GARDAM.

The family members were gathered in the RCMP office with Cpl. VARDY where all sat around the phone which was placed on speaker. Rear Admiral GARDAM expressed his sympathy to the family and went on to explain the Militarys position of the search. He wished to express these views to the family prior to making a media statement. The family was quite upset and had many unanswered questions during and following the phone conference. The family felt that the Rear Admiral had a written statement to relay to them but could not answer any of the questions posed to him.

Following the phone conference, Cpl. VARDY was left with a family that was upset, dismayed and angry at the Military's handling of the search and the family itself. The family assured Cpl. VARDY that they had no ill feelings toward the RCMP's efforts nor the efforts of the ground search as they were present throughout and felt that all was done that could be done with the resources on hand.
