Synopsis of Case

[2020-10-27

0852Hrs Unit 251, Cst J. Burry #818 responded to [REDACTED] Hy, CBS to a report of a missing person. Complainant, [REDACTED], called the police to report that [REDACTED] was for the third time from the [REDACTED]. He often goes into the woods and stays there. [REDACTED] is 51 years old, last seen around 0730Hrs this morning wearing dark blue jeans, black T-shirt, grey sneakers, zip up PUMA hoodie grey with orange trim and he does not have a cell phone.

0858Hrs Cst Burry arrived in the area and spoke with CN on the phone. CN advised that she received a call from night staff around 0744Hrs this morning advising that [REDACTED] had left, no where to be seen on the property. CN said that he was in a good mood, he ate his breakfast and too his medications. CN advised that [REDACTED] does walk to the Orangestore, Pipers and Tim Hortons. Cst Burry advised that he would search around for [REDACTED] prior to obtaining a statement and a missing persons report.

0905-0938Hrs Cst Burry searched around the around, checking side roads and business with negative results.

0950Hrs Cst Burry completed a missing persons report and obtained a written statement from CN, [REDACTED].

1003Hrs Cst Burry called Sgt Deacy and advised him of teh missing person. Sgt Deacy advised taht he would speak with the duty officer and get back to me.


1040Hrs Sgt Deacy advised that ROVERS have been requested and will be attended to conduct a search.

Rovers arrived onscene and setup command post at the old RONA parking lot on CBS HY. Rovers members as well as RNC members were searching for [REDACTED].

At approximately 1610Hrs the ROVERS located [REDACTED] hiding in a wooded area off Pond Rd, CBS near the ROVERS command post. [REDACTED] was hiding in a sitting hut along the river.

[REDACTED] told police that he will not go back to the [REDACTED], he doesn't feel comfortable there and would rather die than go back. [REDACTED] said that he wants to go to [REDACTED] to live where he ha family.

I contact Rovers command and they conducted a call out for a search with a muster point of the old Ronna building in Kelligrews off route 60.

11:55 I arrived on scene and several of the rovers vehicles along with searchers were already on scene and gearing up.

15:00 No new sighting from teams or from Public. Teams have serached to Napa on the trail system and have cover tail to Seal Cove. Still have two teams out in vehicles driving the roadway plus two police units. ATV and Argo still driving the trail system and other side trails in the area.

16:05 Received a call from Comm Center that ██████████ had been spotted in the area of Pond Road about a hour ago. Had All teams responded to the pond rd area.

16:16 ██████████ was located by team 1 in the woods beside Pond Rd. They

At this point staff from the home attended scene and they were informed that Mr. [REDACTED] would be taken the PAU to been seen. Also Adult Social Services was contacted.

16:45 All Rovers and Rovers assists have been returned to Rona and were on way back to the Rover building.
