#### Conclusion

- was located 2.8 kms from the Foxtrap manner (PLS)
- In total volunteers provided 536.26 hours searching for during this search
- Rovers Sar search for an and on 4 separate occasions within the span of 2 month and in total spent 1,426.3 hours searching for a searching overall
- In later searches there was a difficulty in getting a strong response from volunteers as kept going missing and didn't want to be found.
- It was noted that **a second did** not want to be in town and wanted to be back in **the second** with his family. There was frustration that this couldn't happen sooner.
- Following every search there was small changes made but kept getting away.
- Communicated with the RNC that he knew he was doing wrong and that he would hide from RNC and searchers.
- We had sent searches out with minimal PPE when required to ensure we blended in with the public and not looked like searchers.
- We also used personal vehicles on the roads to complete road searches.

Note: Anything highlighted in yellow was inputted from Cst. Andrews notes and was not in our original logs.
